

Racers rescued

Warrior Adventure Race competitors were lost in kayaks on the coast

Warrior Adventure Racing hosted a soldout Sea-to-Sea Florida race which started on Thursday, Feb. 22 in St. Marks.

The day's race was on foot down the rail trail and an endurance race from the boat ramp at Fort San Marcos and ending at the Aucilla boat ramp at Mandalay.

After three race contestants were identified as not on course and with cold weather conditions worsening, there was no time to waste.

By use of their professional boating expertise and extreme knowledge of the local water, Charter Captains Leif Lundquist of Viking Coastal Charters out of St. Marks and Aucilla Outlaw Charters Captain Joel Baldree turned into instant heroes when they located and brought back to safety the three lost race contestants. One man in kayak solo and a mother/daughter team together in a canoe were the vessels lost.

"The guy in the kayak was probably on the verge of death," said Capt. Lundquist. "He didn't know who he was, he was lethargic, he tried to stand up and he would fall down, he must have fallen at least three or four times. His face was white, and his throat was black and

gray. We put him in the airboat and strapped his kayak to the airboat.

"The kayaker had no expressions when he was saved, he just kept saying "thank you, thank you.' Then he would say, 'Who are you? Who are you? Are you from the race?" Lundquist replied: "No, sir, we are the redneck 911 here to get you out of here."

Lundquist was operating a safety boat to make sure the contestants make it around the lighthouse. "I was supposed to have the day off, the race people went to Shields Marina to rent a boat. by the race's insurance standards they must have a safety boat, but no one had the qualifi-Turn to Page 16



Increase in fiscally constrained distribution

Wakulla will receive an additional \$625,500 over last year in payment as fiscally constrained county **By WILLIAM SNOWDEN** Editor

Property Appraiser Ed Brimner put out a news release this week noting that the county will receive an additional \$625,500 from the state, monies received by fiscally constrained counties.

The county is facing a \$2.4 million shortfall in the budget because of a \$307 million valuation error by the property appraiser's office for a vacant lot in Lake Ellen. The additional money from the state would appear to be enough to plug the \$600,000 hole still in the county budget.

Anticipating a larger budget this year, county commissioners had approved nine new positions in the sheriff's office - most of them road deputies - as well as additional firefighters and other county employees. Those positions were immediately frozen by commissioners when they realized they faced a major hole in their budget.

Brimner's release appears as a column on this week's Opinion Page, page 4.

At a recent county audit committee meeting, Brimner noted that property tax values in the county were up \$142 million so far this year from \$2.046 billion last year to \$2.187 billion as

School board revisits policy

Chair Cale Langston wants to reevaluate required transport for teams

In the discussion portion of last week's school board meeting, Chair Cale Langston informed fellow board members that he is investigating the requirement that sports teams and clubs be transported by school personnel and vehicles.

Langston said he was looking into the matter over concern that some teams and clubs - newly recognized as Tier 1 organizations not required to pay rent for facilities want parents to transport the students.

For example, Langston noted that one travel team plays in Tampa and Atlanta - and that parents, not the district, had been responsible for travel in the past.

Langston said he had talked to other districts about the matter, and had contacted the Wakulla district's insurance provider to see if there would be an issue.

There was no action taken on the issue at the meeting on Monday,

drawn.

Feb. 20. But other school board members indicated they were supportive of the change.

Then discussion shifted to a proposal put forth by school board member Melisa Taylor and withdrawn before the meeting that would have prohibited public comment at workshops.

Members Laura Lawhon and Eddie Hand brought up the withdrawn policy, though Taylor questioned why it was under discussion since it had been with-

Taylor did say, however, that "Some school board members have been adversarial with district staff for political

reasons." Lawhon said she thought she was being referred to in Taylor's comments.

Hand said he was "very dissatisfied" with the proposal being taken off the agenda, calling it a "chicken move." Hand indicated he felt the proposal should have been put to a vote.

Lawhon made a call for more collective work by the board, and Taylor responded: "My biggest problem is that the board is not working together."

The meeting closed with Lawhon claiming a citizen appearing at a school board meeting was accosted by a district staffer who questioned why they were there. Asked after the meeting who was the citizen, Lawhon said she couldn't divulge the name of the person without permission.

An 18-year-old Crawfordville teenager was critically injured in a car crash near the intersection of Shell Point Road and Live Oak Island Road on Wednesday, Feb. 21, around 3 p.m., according to Florida Highway Patrol.

The car was traveling north on Shell Point Road approaching the intersection with Live Oak Island and ran off the roadway to the right and onto the east shoulder, then over-corrected to the left causing the car to rotate across the road onto the west shoulder where it struck a utility pole, ejecting the driver, who was not wearing a seat belt.

The injuries suffered by the male teen were reported as critical, and the teen was transported to Tallahassee Memorial Hospital by Survival Flight.

FHP does not release names of those involved in crashes.

Troopers were assisted on scene by Wakulla Fire Rescue and the Wakulla County Sheriff's Office.

Fatal deer disease limited to one case

After a deer killed in June in Holmes County tested positive for a contagious fatal disease, it remains the only detected case in the state, Florida Fish and Wildlife Conservation Commission Executive Director Roger Young said Wednesday.

But for now, the commission will continue to test deer for chronic wasting disease.

The effort includes an "enhanced surveillance zone" in Holmes, Jackson and Washington counties, where deer must be tested before being processed for food or going to taxidermists.

"We have more than 1,000 samples collected from within the enhanced surveillance zone that have been tested with no additional positive cases," Young said during a commission meeting in Tallahassee. "So, from 1,000 tests from this past season and before, we still only have one positive (chronic wasting disease) case, which is great news."

Young said a meeting is planned for April to outline "potential future management actions."

The disease is described as similar to mad cow disease, with deer becoming emaciated and often being found isolated and trembling.

While not considered harmful to people, the

Flower of the Week at Sopchoppy Depot Park Soldier orchid

Soldier orchid (Zeuxine strateumatica) is a small orchid native to Asia that popped up in the northeast garden at Sopchoppy Depot Park. This terrestrial orchid arrived from China in 1927 in a shipment of centipede grass seed and is now naturalized throughout the southeast. For about 2 weeks in late winter, 6-8-inch-tall stalks emerge bearing whiteand-yellow, self-pollinating flowers that small flies will visit. This orchid prefers moist, rich soil in full or part sun, needs a special bacterium around its roots, and is hard to transplant. Also called lawn orchid, this perennial acts more like an annual. We landscaped Depot Park with plants native to our area -- and we battle invasive nonnatives like camphor trees. However, this nonnative appears randomly and does not seem to disrupt natural habitats.





Fiscally constrained distribution up

The Florida Department of Revenue recently announced Wakulla County is receiving \$2,006,736 in Fiscally Constrained County funds in 2024. This is a \$625,529 increase from the \$1,381,207 received in 2023. Why is Wakulla receiving this money from the State of Florida and why did it increase?

The legislature provides citizens and businesses with many tax breaks including Homestead exemption for homeowners and Tangible Personal Property (TPP) tax breaks for businesses. The Wakulla County Property Appraiser constantly searches for people and businesses who can benefit from these breaks to both inform them and assist with the required forms. Legislators recognize these tax breaks might mean small counties are unable to raise enough

funds to operate their in no new taxes for the governments. With this in mind, they passed additional laws to partially compensate "Fiscally Constrained Counties" due to the state-mandated tax breaks. Since Wakulla County is a "Fiscally Constrained County, the State is providing \$2,006,736 to partially hold Wakulla County harmless for state-mandated 2023 tax breaks.

One source of increase is business TPP. The first \$25,000 of a business's TPP is tax free. Historically, it appears Wakulla County made little effort to track small businesses whose TPP filing would be less than \$25,000. After all, why make small businesses fill out another form that resulted in no taxes and is a bureaucratic waste of time. But is it a waste of time? As it turns out, the State essentially reimburses the lost taxes due to the \$25,000 exemption for businesses in Wakulla County. In 2021, I assigned Mr. Chuck Turner the responsibility to locate every business in Wakulla County, no matter how small, and ensure they filed a TPP return as mandated by State law. Since then, hundreds of new TPP accounts have been established that resulted

business owners while increasing our Fiscally Constrained County distribution from the State. Despite paying no taxes on the first \$25,000 of a business's TPP value, small businesses establishing a TPP account with this office results in large dividends to the county coffers.

As the Wakulla County Property Appraiser, my goal is to provide Honest and Impartial Assessments. This office is responsible for providing assessments for both Real Property and business Tangible Personal Property. We also track all exemptions and annually apply for distribution of fiscally constrained county funds. Accurate tracking of these exemptions results in higher distributions and better funding for our county.







SOUTHERN FLOUNDER

(Paralichthys lethostigma) Flounders are a type of "flat fish". As the young larvae develop, one eye migrates across the head so both end up on the same side. They lie flat, eyes up, and can change their color to blend in. They hide from predators and ambush small fish prey with their studded teeth. 

Regardless, any day of diving is better than work.

Back to my question of are you ready, there are two things that need to be ready for scuba diving. The first one is your equipment from your personal gear - i.e mask, snorkel, booties, and fins to your regulators. Let's check out your personal gear first.

Your mask: If you haven't used your mask since your last dive last summer you will need to take it out of your gear bag and check several key areas.

Look at the strap to make sure it's free of any little cracks when you stretch it out, if it is then you need to replace it.

If it's got mold on it then replace it.

If the part of it that goes in the frame of the mask where you pull the strap to adjust it is slightly torn, replace it.

Look at the lens to make sure sure it is clear and not scratched or cracked, if it is then you will need a new mask.

Look at the silicone skirt around the frame to make sure there are no cracks or punctures for a possible leak path. The only thing you can really replace will be the strap itself.

Now look at your snorkel, if the mouthpiece is cracked or torn it's time for a new one.

Look at your booties to make sure they are not torn and that the zipper is not locked up by salt. Sometimes you can soak them in warm fresh water and it will dissolve the salt deposits and the zipper will work free, if it doesn't then its time to get new booties.

If you are using a dive computer that requires replacement batteries then hopefully you stored it without the batteries installed, if not you run the risk of the batteries off gassing and corrosion on the contacts.

Sometimes you can take a small wire brush and clean them.

If you stored it properly then put new batteries in it and it should work fine.

I will cover the rest of your equipment next week.

Later that evening, after supper, we watched TV in the living room, and then she went out into the kitchen. When she returned, she had a







Weekly Roundup: Leaders' priorities prosper

TALLAHASSEE — The Florida Legislature this week passed a bill that is designed to keep minors under 16 from being on social-media platforms, this year's top priority of the House speaker.

But with Gov. Ron DeSantis expressing doubts about the measure, lawmakers could be hedging against a potential veto.

The House on Thursday voted 108-7 to pass the measure (HB 1), a little more than two weeks before the 2024 legislative session's scheduled March 7 conclusion. The Senate signed off on the bill earlier in the week, meaning the governor would have to take action on the bill within seven days.

DeSantis has made several statements in recent weeks questioning the legality of the bill, that it could get the governor's veto pen. If it does, lawmakers could come back to the table before the end of session to reconsider the measure. Republican supermajorities in both chambers also could potentially override a gubernatorial veto — an option not exercised by state lawmakers in nearly 15 years. Speaking about the bill before the House passed it Thursday, De-Santis suggested the bill could have potential implications for Floridans' parental rights. The governor pointed to the bill affecting 14- and 15-year-olds.

I think, answers the concerns that a lot of folks have," DeSantis said. "Because I do think parents are concerned about social media and what goes on there. And I do think they think it's a problem. But I also think that for people that are in high school, it's not as simple. I think you've got to have some parent involvement."

The measure would place various requirements on social-media companies, including preventing children under 16 from creating accounts on at least some platforms. The bill also would require platforms to terminate existing accounts that they know or have "reason to believe" are held by minors younger than 16 and allow parents to request that minors' accounts be terminated.

The restrictions would apply only to companies leading to speculation that meet certain criteria, including issues related to algorithms, "addictive features" and allowing users to view the content or activities of other users. House Speaker Paul Renner, R-Palm Coast, made the measure a major priority for the 2024 session. Reporters on Thursday asked Renner whether he expected DeSantis to veto the measure. "I don't know, I don't know what the governor is thinking," the speaker said. Renner also touted the bill, saying that "we worked with everyone, really all stakeholders, from the first moment." "We've taken a little bit more time to get to where we are. But we

get there in a way that, think we have a really good product, we're really excited about it, both being effective and constitutional," Renner told reporters.

> Meanwhile, tech industry groups such as the Computer & Communications Industry Association, have signaled the bill likely would face a court challenge if signed by De-Santis.

The association said in a statement this week that the bill "puts young Floridians at risk by restricting their First Amendment right to access information and forcing companies to collect additional sensitive data on internet users."

The main bill, SB 7016, includes \$717 million in spending. Among other things, it would provide money for increased residency slots for doctors and put additional dollars into loan-forgiveness programs for health-care professionals.

The bill also seeks to take workforce-related steps such as helping clear the way for foreign-trained physicians to practice in Florida, and includes issues such as trying to shift patients away from hospital emergency rooms for non-emergency conditions.

The other bill, SB 7018, includes providing \$50 million a year for a revolving-loan fund program for health-innovation projects. The program would provide loans with a maximum interest rate of 1 percent, with priority given to applicants such as rural hospitals and organizations that provide care in medically under-

On Thursday, Feb. 15th, the Leon sheriff's office's Financial Crimes detectives arrested Allen on charges including two counts of

Larceny from Persons over 65 years of age, two counts of Grand Theft \$750 or more, but less than \$5,000, and four counts of Organized Scheme to Defraud \$300 but less than \$20,000.

The collaborative effort continued on Friday, Feb. 16, as Wakulla's Criminal Investigations Division secured seven arrest warrants, charging Allen with seven counts of Grand Theft \$750 or more, but less than \$5,000.

On Monday, Feb. 19, Leon deputies arrested Allen on the warrants from Wakulla County. Subsequently,

he was transferred into the custody of Wakulla County deputies to face charges in their jurisdiction.

Lundquist said, "When we got to the boat ramp one of the guys from the race had an app that tracked all the contestants and as soon as we got the coordinates, we were able to locate the missing boaters. We then went to locate the girls, once we looked at the area, we were able to go straight to them. We were advising the girls to push towards the shore so we can get in the shallow water to get in the marsh and towards the land

and we can find them. "The women were hap-

py, they were thanking us, they were a mother and daughter team," Lundquist said. "The daughter mentioned she was always worried when her mother went out on races that something would happen, so for this race, the daughter decided to join her mother in the canoe and this is what happened."

The entire rescue mission took about an hour once the captains got the boat on plane. "We got to the boat ramp at 7:30 and back at JR's at 10 p.m.," Lundquist said. "We were on the water about an hour and

a half total rescue time."

Lundquist is a member of the Boater Safety Council and is certified by the National Safe Boater Council and teaches people how to drive boats properly and safely.

"Kayaks and canoes do not do well in the big water, they are not made for it," he said. "It was a very risky thing to do."

"There were three people out there making the wrong turns in direction, we found them, they were only lost - they did not want our help in order to keep going and stay in the race; they continued on with the race."

When asked how it feels to be a hero and rescue people, Leif said "I don't feel different, when someone is in danger, it is nothing out of the ordinary for me to help someone."

served areas.

Passidomo has said the bills are needed, at least in part, to meet health needs as the state continues to grow. For example, one of the bills includes providing money to expand medical residency programs to try to keep more new doctors in Florida.

WHAT'S HAPPENIN', CHAPLAIN

The House also on Thursday passed a bill that would allow school districts to authorize volunteer chaplains to provide "support, services and programs" to students in public schools, amid a debate about whether the bill would be constitutional.

Under parts of the proposal (HB 931), chaplains would have to meet background screening requirements, and school districts or charter schools would have to get parental consent before students could receive chaplains' services.

Supporters of the measure say allowing chaplains would add another tool to help schools address children's mental-health issues.

Several House Democrats and the American Civil Liberties Union of Florida have argued the bill is unconstitutional. "Courts have repeat-

edly ruled that it is unconstitutional for public schools to invite religious leaders onto campus to engage in religious activities, such as prayer and religious counseling, with students," Kara Gross, legislative director and senior policy counsel for the ACLU of Florida, said in a prepared statement.

The measure would need approval from the Senate before it could go to Gov. Ron DeSantis. Passidomo and Senate bill sponsor Erin Grall, R-Vero Beach, said Thursday they think the bill would pass constitutional muster.

"I think that it actually is squarely within the Constitution. Not only would parents have to consent to the consultation with a specific chaplain. But there's also, they can't prevent any specific chaplain from being a part of the program either, based on religion. So, these are the bare minimum guidelines to participate," Grall, an attorney, said.

of Jan. 16. That too will relieve some of the financial strain faced by the county next year.

At the county commission meeting on Feb. 20, commissioners approved a budget amendment that reflected the lower-than-budgeted revenues.

The original budget estimate for the county was \$17.64 million. At the Feb. 20 meeting, commissioners approved a budget amendment with actual revenues of \$15.5 million.

At the meeting of the audit committee a couple of weeks ago, Clerk of Courts Greg James and County Administrator David Edwards noted that holding off on hiring new deputies would save \$900,000 this year – and the same amount for holding off hiring new firefighters. There are a number of other county positions coming open - for example, to staff the new Wakulla Sands golf course.

disease can result in death to deer within four months.

The positive test in June was the first known case of a deer in Florida having the disease, which has been found in 30 other states including Alabama and Mississippi.

With no simple treatment or vaccine for chronic wasting disease, deer farmers have expressed concern that a single positive test could require the eradication of entire herds, which in some cases represent millions of dollars in investments.

Florida has monitored the issue since 2002. In 2021, the state placed certain limits on importing deer carcasses into Florida. People can bring in deboned meat, finished taxidermy mounts and clean hides and antlers.
